## CONSENT AND RELEASE

PACIFIC WOMEN'S CIRCLE ASSOCIATION (PWCA) has been formed to carry on the work of its predecessors integrating spirituality into the lives of women. The program this year is the Women's New Moon Retreat. We will be using cameras and microphones to record the special events and moments of the retreat. We also want to make sure that you can record your own experiences at the Retreat. There may be individuals or groups who offer a variety of services to Retreat participants. These individuals or groups are not associated with PWCA and PWCA has no control over the activities or products they may offer. There are a variety of activities available at the Cowichan Lake campsite such as swimming, boating and hiking. These activities are not part of the Retreat program. The following statement provides permission to all of us for use of recording devices and also provides a general release from liability for PWCA. It is worded, necessarily, in legal language.

In the event that I, the undersigned, elect to participate in the Women's New Moon Retreat sponsored by PWCA, an association formed under the British Columbia Society Act, to be held from August 9 – August 14, 2010, at Cowichan Lake Education Centre, British Columbia, I understand and agree that:

PWCA is permitted to photograph, film and record (or authorize others to photograph, film and record) audio and video tape recordings of activities and persons, including myself, while participating at the New Moon Retreat for reasons related to documentation of the Retreat. I expressly grant to PWCA, and its licensees, assigns, successors and agents, an irrevocable, non-exclusive right to use my name, voice, photograph and/or likeness incorporated into or embodied in the recordings in connection with any derivative use(s) of the recording without any further obligation of any kind to me.

I fully understand and agree that PWCA does not accept responsibility in whole or in part for any liability, loss, accidents, personal injury, sickness, medical expenses, lost income, claims or property damage

occasioned by any cause whatsoever related to or occurring during or in connection with the New Moon Retreat including without limitation the fault or negligence of any person, employee or company entrusted with the performance or any services rendered during the New Moon Retreat. I further agree to release and discharge PWCA and its employees, representatives and agents from any loss, expenses, liability, claims, damages and other injuries arising out of or in connection with my participation in the New Moon Retreat or any activities related to it, whether caused by the fault or negligence of any person, employee or organization connected with PWCA, or from any cause.

I further understand and agree that PWCA does not assume responsibility and that I do assume responsibility for safeguarding any valuables and personal property that I bring to events sponsored by PWCA.

I have read and understand the meaning of this Consent and Release Agreement and I enter into this Agreement of my own free will.
